**ORDER OF DISMISSAL**

Pursuant to Rule 41(a)(2) of the Federal Rules of Civil Procedure, and with the consent of Plaintiff Coastal Counties Workforce, Inc. (“**CCWI**”) and Defendants Paul R. LePage and John Butera (the “**State Defendants**”), this Court ORDERS as follows:

1. This Court’s Order on Plaintiff’s Request for Permanent Injunctive Relief and Plaintiff’s Motion to Consolidate (ECF No. 64) (the “**Permanent Injunction Order**”) shall remain in effect until August 30, 2019.
2. Plaintiff is required to file its Fee Petition within 30 days of the date of this Order in the event the parties are unable to agree on the amount of attorneys’ fees.
3. This Court shall retain jurisdiction over the parties in order to the extent necessary to make a determination regarding Plaintiff’s Fee Petition, if one is filed, to otherwise resolve any disputes regarding fees, and to enforce the Permanent Injunction Order and the terms of this Order.
4. This action is dismissed without prejudice conditioned upon the terms of this Order.
